Health Guarantee

This puppy is guaranteed to be free from any disease or genetic defect, as determined by a licensed veterinarian, for a period of one (1) year from the date of sale.

If within this period the dog is found to have a genetic defect that affects its quality of life, the buyer is entitled to a replacement of equal value and gender, provided:

- A signed, notarized statement from a licensed veterinarian is submitted, detailing the breed, age, history of care, and diagnosis.
- Upon receiving such documentation, the seller reserves the right to have the dog examined by a veterinarian of their choosing. If there is a dispute, both parties may mutually select a third-party veterinarian to resolve the issue.
- All transportation costs for returning the dog are the buyer's responsibility.

Registration Information

This puppy is registered (or eligible to be registered) with the following organization(s):

The buyer is responsible for completing all necessary registration paperwork within 30 days of purchase and must include the prefix "**KIK**" in the dog's registered name.

Veterinary Examination

The buyer must have the puppy examined by a licensed veterinarian within three (3) days of delivery. Failure to do so will void the health guarantee.

This health guarantee does not cover conditions arising from injury, environmental factors, neglect/abuse, joint health issues, or skin conditions. If the dog is returned, the seller may quarantine the dog for two weeks at the buyer's expense before any refund or replacement is considered.

Care and Confinement

The buyer agrees to provide the dog with responsible and adequate confinement to prevent escape, injury, or harm. This includes promoting responsible dog ownership and ensuring the dog reflects a positive image of its breed.

The buyer also agrees to provide proper food, water, shelter, exercise, veterinary care, and socialization.

The seller recommends enrollment in obedience training to foster proper communication between the buyer and the dog.

Microchipping is highly recommended to aid in the return of the dog if lost or stolen.

Rehoming & Surrender

If the buyer can no longer care for the dog, they must notify the seller before surrendering the dog to a shelter, pound, rescue, or any animal welfare organization.

The buyer agrees to rehome the dog responsibly, with the seller's assistance if needed. In the event no suitable home can be found, the buyer should attempt to place the dog with a no-kill shelter or rescue.

The buyer is aware that many shelters and rescues have policies that result in the euthanasia of certain breeds, including French Bulldogs, and agrees to make every effort to avoid this outcome.

Spay/Neuter Clause (if applicable)

If this puppy is sold as a pet and not intended for breeding, the buyer agrees to spay or neuter the puppy by:

Proof of the procedure must be provided to the seller within seven (7) days of completion.

Failure to provide proof of spaying/neutering by the agreed date will result in a breach of contract, and the seller reserves the right to take legal action or reclaim the puppy.

The health guarantee becomes void if the dog is used for breeding without prior consent from the seller.

Non-Refundable Deposits

All deposits are non-refundable. However, deposits may be transferred to another litter, puppy, or adult dog from the seller's future offerings.

Payment & Processing Fees

All credit card transactions are subject to a 3.5% processing fee. By completing a payment, the buyer acknowledges the charge and agrees not to dispute any valid charges processed through the authorized payment method.

Payments are final and non-revocable once processed.

Buyer Obligations

The buyer agrees to provide adequate food, water, shelter, exercise, health care, and socialization for the puppy.

Enrollment in obedience training has been recommended to help the buyer understand effective means of communicating with the dog.

Participation in microchipping has been encouraged to ensure the return of the dog if it becomes lost or stolen.
